

NOTICE TO THE MARKET

Estácio Participações S.A. ("Estácio" or "Company" - Bovespa: ESTC3) hereby informs the market and the public in general that we concluded the **intake and renewal cycle for the second semester of 2014.**

The intake cycle of the **on-campus undergraduate** segment brought around 67,500 new students to our student base, a 5.8% higher than in 3Q13. Thus, the same shop on-campus undergraduate student base grew by 17.0% over the same period last year, totaling 303,300 students by the end of 3Q14.

Considering the acquisitions concluded in the past 12 months (Literatus, IESAM, Uniseb and ASSESC), the total undergraduate student base reached 315,700 students, which represents growth of 21.8% over 3Q13.

In the **distance learning undergraduate** segment, we enrolled around 27,000 new students, meaning an organic growth of 29.8% over 3Q13. The same shop distance learning undergraduate student base grew by 24.2% year-on-year, totaling 78,400 students by the end of 3Q14.

Considering Uniseb students, the total distance learning undergraduate student base climbed to 105,700 students, 67.4% up on 3Q13.

The **total undergraduate student base** totaled 421,400 students at the end of 3Q14, 30.7% up when compared to 3Q13.
